- 4. **Qualifications of Membership**. By signing this Application for Playing Privileges, the undersigned represent that the above information is true and correct and hereby authorizes Stonewall and its representatives to conduct such inquiry into the undersigned's qualifications for membership as they deem appropriate.
- 5. *Membership Approval Process*. The undersigned understands that membership at Stonewall is subject to approval. In the event this Application for Membership Privileges is acted upon favorably. Stonewall will so notify the undersigned and invite the applicable to membership. If this Application for Membership Privileges is not acted upon favorably, Stonewall shall notify the undersigned that he/she will not be invited to membership.

- 6. Membership Privileges. The undersigned understands that Members of Stonewall are allowed to use the facilities provided in accordance with this Membership Plan. By obtaining a membership at Stonewall, Members obtain a non-exclusive revocable license to use the facilities in accordance with the classification of membership selected by the Member. Members do not obtain any equity or ownership interest in Stonewall or the facilities provided at Stonewall, do not have and do not acquire any property rights or other interest in any property of Stonewall, do not have any rights to become involved in the management or operation of Stonewall or the facilities provided at Stonewall and are not subject to any assessments for operating deficits incurred in the operation of the facilities provided at Stonewall or any assessments for capital improvements to its facilities.
- 7. *Modification and Termination of the Membership Plan*. The undersigned understands that Stonewall reserves the right to discontinue operation of any or all of its facilities, to change its facilities available for use by Members, to terminate this Membership Plan, to terminate all memberships at Stonewall with or without cause, to terminate any particular membership category at Stonewall with or without cause, and to sell, lease or otherwise dispose of its facilities, in whole or in part, to any other third party. Stonewall also reserves the right to at any time to terminate a membership for cause without any refund, or without cause with a pro rata refund of dues for the year in which termination occurred.
 - In addition, Stonewall further reserves the right to amend and modify this Membership Plan in any manner it deems appropriate, in its sole discretion.
- 8. *Indemnification and Assumption of Risk*. By executing the Application for Agreement for Playing Privileges, Applicant hereby agrees to indemnify, defend and hold Stonewall (and its partners, officers, operators, employees and agents) harmless from and against any and all liabilities, costs (including reasonable attorney's fees), claims, demands or damages incident to or arising out of or relating to the acts or omissions of Applicant, their family or guest(s), and their respective use of occupancy of Stonewall's facilities. In addition, by executing this Agreement, Applicant hereby voluntarily assumes all risks of accident or damage to Applicant's person or property, and the person or property of Applicant's family and guests, arising out of or relating to the use or occupancy of Stonewall's facilities including but not limited to errant golf balls, operation of golf cart, and adverse weather conditions including lightening.
